- Equipment, Rent & Term of Rental Agreement:** The Undersigned, as lessee, hires from INFLATABLE FUN, as lessor, one INFLATABLE FUN unit: _____ The rental fee as stated above payable.
- Special Instructions:** The INFLATABLE FUN unit's equipment is reliable. Should INFLATABLE FUN unit begin to deflate, check: 1) The motor has stopped in which case check the cord connection at the outlet near motor and remember to keep only the 100 foot extension cord on the outlet, 2) If the motor is continuing to run, check the air intake on the side of the motor for blockage and check both tubes at the back of the INFLATABLE FUN unit for snugness, re-tie if necessary, 3) If you cannot correct the problem call 336-852-7555.
- General Rules** to follow during use of the INFLATABLE FUN unit:
 - Only compatible age groups and size shall play in the INFLATABLE FUN unit at the same time. The maximum numbers of riders of each group that should play in the unit at the same time are:

Unit Size	Children 8 & Under	Children 8 to 12	Older Teens	Adults
15x15	5 - 8	4 - 6	3 - 4	2 - 3
 - All riders **must remove their shoes** before playing in the INFLATABLE FUN unit.
 - To avoid neck and back injuries, **Flips are not allowed.**
 - **Children's safety depends on you. Your personal supervision is absolutely required.** Operator must be at least 18 years old and present at all times. **As the Lessee of the INFLATABLE FUN unit the safety of all riders is your responsibility.**
 - Absolutely no gum, candy, food, "silly string" or other sticky substances are allowed in the INFLATABLE FUN unit.
 - **Do not move** the INFLATABLE FUN unit from the place where it was installed. If the INFLATABLE FUN unit moves, pull the corner back to its original location of installation. Absolutely, keep the INFLATABLE FUN unit away from swimming pools.
 - No pets inside the INFLATABLE FUN unit.
- Safe operation acknowledgement:** Lessee acknowledges that he/she has been instructed about and fully understands the safe operation of the INFLATABLE FUN unit and Lessee agrees to observe all safety precautions.
- Maintenance:** Lessee agrees to keep the INFLATABLE FUN unit in the same condition as when received.
- Release of Liability:** The Lessee shall be in charge of INFLATABLE FUN unit's operation, and is fully responsible for operation after receiving unit. Lessor is not responsible for any injuries occurring to Lessee or to any persons using the leased property. Lessee further agrees to hold Lessor free and harmless against any claims; and further, Lessor shall be indemnified for any and all costs incurred due to claim from anyone; including court costs and attorney fees; and other related costs involving the use of this leased equipment. Lessee will provide own liability insurance unless otherwise specified. Lessee is responsible for the replacement value of the new leased unit in the event of theft, vandalism, fire or any act which may damage or destroy the leased property.
- Title to INFLATABLE FUN:** Lessee agrees to keep the INFLATABLE FUN unit in his/her custody and not sublease, rent, sell, remove or otherwise transfer such INFLATABLE FUN unit. The INFLATABLE FUN unit will remain in the property of the Lessor and may be removed by Lessor at any time after the termination of this Rental Agreement.
- Rain Policy:** During periods of severe weather conditions (i.e. rain, high winds, etc.) we reserve the right to cancel your reservations. If conditions are not too severe we will give you the option of keeping it or not. If you decide to keep the unit for the term of the Rental Agreement there will be no refunds.
